## **Explanation of Responses:**

1. Represents common units of limited partnership interest ("Common Units") in Armada Hoffler, L.P., the operating partnership (the "Operating Partnership") of Armada Hoffler Properties, Inc. (the "Company") and of which the Company is the general partners. The Common Units were received in exchange for assets contributed to the Operating Partnership on January 17, 2014, and were valued at \$11.50 per Common Unit, which was the initial public offering price per share of the Company's common stock. Commencing one year from the date of issuance, each Common Unit is redeemable for cash equal to the then-current market value of one share of the Company's common stock or, at the election of the Company, one share of the Company's common Units have no expiration date.

2. Reflects a correction to the total number of Common Units held by Mr. Haddad. In the Form 4 filed on 11/4/13, the number of Common Units acquired on 5/13/13 should have been 1,892,779, rather than 1,897,126 and after the purchase of the 4,347 units on 5/22/13, the total should have been 1,897,126, rather than 1,901,473.
